

**Contract**  
**Tree & Stump Removal**

This CONTRACT, made this 1<sup>st</sup> day of January, 2017, between the VILLAGE OF NORTH HUDSON (hereinafter called "Village"), and ST. CROIX SAVATREE (hereinafter called "Service"), to wit:

Commencing immediately, Service will remove trees and stumps from public property within the Village within twenty (20) days after receiving orders therefore from the Village Forester, which orders shall be written and retained by Service, at the following rates:

Tree removal, including clean up and hauling away of limbs, trunks and debris for disposal in an approved landfill site or other approved method (not including stump removal).

\$270.00 / tree

Stump removal, including cleaning up and hauling away of debris for disposal in an approved landfill site or other approved method (except when the Village may require some or all of the debris to be deposited as fill in the stump hole).

\$65.00 / stump

Removal of brush/tree piles as requested by the North Hudson Public Works Department, including limbs, trunks and debris for disposal in an approved landfill site or other approved method.

\$375.00 / load-30 yard box

Service will be expected to complete its work within a three month period which shall commence on a date directed by the Village Forester, and in any event, not later than October 31<sup>st</sup> of each year.

On the 15<sup>th</sup> day of each month Service shall have delivered to the Village Clerk a statement covering services performed subsequent to previous statements and through the date of the current statement for all trees removed from public property only, along with form indicating completion dates of work directed by Forester to Service.

This contract shall include all other applicable provisions of the Specifications and Contract Documents of the Village of North Hudson (entitled "SPECIFICATIONS") which were attached to Contract between Village and Service dated December 14, 1985.

This Contract shall expire on December 31, 201\_ unless sooner terminated pursuant to the provisions of said Specifications and Contract Documents being herein made a part of this contract.
