After reviewing the letter and diagram provided by Mr. Nelson, I recommend the following conditions:

- 1) Area outside of building to be completely enclosed with fence and the extended premises accessed only from within the building.

- 3) Use of outside area only with specific permission of Village Board for requested date and times.
- 4) Owner to provide equal amount of adjacent substitute off-street parking while parking lot is fenced during time of event.
- 5) Owner to be responsible for Band / Music volume.



**Liam Loughney is a fun loving, energetic 2.5 year old boy. He is the son of Heather and Brian Loughney who reside in Hudson, Wisconsin. He will become a big brother this April!**

Liam's journey with cancer began on January 11, 2016 when Heather noticed an oval shaped lump, about 4 cm long, under Liam's left armpit.
