


Thoroughly clean the existing surface with a self propelled broom. Apply 170 degree emulsified asphalt by full-width spray distributor. Apply Dresser Trap FA2 cover aggregate and spread uniformly over surface with full-width self propelled chip spreader. Roll with 2 pneumatic-tired roller. (Pick up sweeping included)

Krattley Lane North: \$14,151.13

10th Street North: \$17,600.36

Spray Patching

Clean areas with compressed air. (Approx. 260 cu ft of air / min) Apply tack coat of heated emulsion oil. Inject oil coated 1/4" fractured spray stone.

Per Production Hour \$550.00 x 8 hours = \$4,400.00 per day

This proposal may be withdrawn if not accepted and received by CONTRACTOR within 30 days of the date above and/ or at any time before performance of the work hereunder upon CONTRACTOR'S determination that the PURCHASER is not creditworthy.
